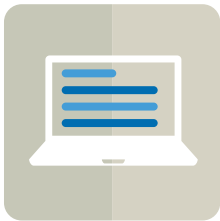

STEP 1: Register

There is absolutely no cost involved and no obligation whatsoever to conduct any transaction with us when you have registered.

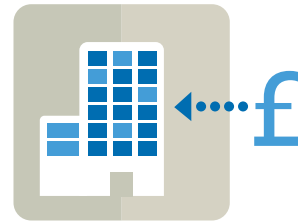


STEP 2: Secure a Rate

Your personal consultant will discuss and study your currency requirements, quote an exchange rate for you and advise you on the amount of foreign currency you will receive.

Once you have accepted the quote, the exchange rate is guaranteed and will not change. The foreign currency you have requested is officially booked for you.

A Trade Note will be automatically emailed to you confirming the exact details of the trade booked, including the currency you have purchased and the rate agreed.



STEP 3: Payment

Send us your funds via electronic transfer to pay for the currency purchased, and using an Onward Payment Instruction tell us where you want the purchased currency to be sent. If you already have beneficiary details on file we can add this for you so you will never have to resend.

We will keep you fully informed of everything that is happening along the way and once we have received your funds, we will forward the currency as per your request.

Spot Transfers

Typically used by corporate clients to pay charges incurred in another currency, for example, to pay for goods or services obtained abroad. It is designed for immediate currency transfers once cleared funds have been received from the client. We offer same day delivery for major currencies.



Forward Contracts

This is used by clients (import & export) who need to fix their exchange rate when purchasing goods in the future so that their re-sell prices can be stabilised. A forward contract can only be fixed for 1 year in advance and requires a deposit of up to 10% with the balance payable upon maturity.



Market Watch

Our corporate consultants will monitor the market with your needs in mind. If they observe conditions in the market that are beneficial for your currency needs, they will be proactive and get in touch with you to make you aware of these conditions and enable you to benefit from them.



Stop/Limit Orders

This allows our clients to issue an instruction to automatically buy or sell currency at a specific exchange rate. This means that we can wait until the rate reaches its best level before we buy currency for you.

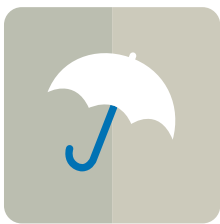

At Worldwide Currencies we adhere to the FCA requirement to 'Maintain a defined level of capital at all times' to cover the operational cost of the company as well as 'Safeguard client funds (by segregating client funds from those of the company)', meaning a client's funds are used for their trade alone and therefore are secured against the risk of loss.

When paying for a trade all funds are internally segregated and held securely within a client account at one of our banking providers. This means we can easily reconcile the accounts, trace funds, ensure company and client funds are definably separated and limit risk to both Worldwide Currencies and the customer.
